Strategic Planning Meeting Summary - April 21, 2026

The Indian Valley Community Services District (IVCSD) Board of Directors held a Strategic Planning Meeting on April 21, 2026, at the District office in Greenville.

Meeting Overview

The meeting was called to order at 5:36 PM by Director Dan Kearns. Directors Wanda Carpenter, Dan Kearns, and Roger Cherry were present. Staff in attendance included General Manager Jamie Little, Operations Manager Charles Slagter, Board Clerk Jessica Johnson, and Office Manager/Communications Specialist Katherine Carpenter (via Zoom).

The agenda was approved unanimously, and public comments were received and are available on the District's website.

Strategic Planning Discussion

The primary focus of the meeting was a **comprehensive discussion of ongoing District projects and long-term planning priorities**. No formal actions were taken.

Key areas of discussion included:

- **Safety Center Development:** Continued planning for construction, funding opportunities, and coordination with partner agencies.
- **Financial Review:** Ongoing efforts to review District finances, including forensic audit work and financial reporting.
- **Fire and Emergency Services:** Planning for operational responsibilities, equipment needs, and potential expansion of services in Crescent Mills.
- **Property Management:** Status of surplus properties and ongoing negotiations with Plumas Rural Services for potential development opportunities.
- **FEMA and Disaster Recovery Projects:** Progress on closing out completed projects and prioritizing use of available funds for infrastructure repair and upgrades.
