




### **Project Benefits**

- Sufficient capacity during routine tank maintenance
- Emergency water storage for well failure
- During normal use, the ability to maintain 1,000,000 gallons of storage
- Reduce energy consumption during peak energy periods by turning off pumps and using stored water.

### **UFR Region Water Supply Reliability Project**

The Upper Feather River (UFR) Region Water Supply Reliability Project focuses on domestic and emergency water storage to address climate change driven changes in supply availability and needs. As precipitation and recharge patterns change with climate change, it is critical that water service providers plan to maximize storage options and identify and develop alternative water sources in response to changing conditions. Additionally, it is imperative that local water storage throughout our region's communities become a high priority. The region's water/wastewater service districts serving DACs have a significant lack of staff, financial, and technical capacities making it extremely difficult to fund much needed upgrades and installation of necessary infrastructure. These projects fall under the IRWM strategies for regional self-reliance, water supply and water quality, and addresses the Human Right to Water.
