Regular Board Meeting – May 6, 2026

The Indian Valley Community Services District Board of Directors met on May 6, 2026, to review District operations, finances, ongoing projects, personnel matters, and other business affecting the community. All five Board members were present.

Board Approves Routine Business

The Board approved the agenda and approved minutes from recent meetings, including the April 15 Regular Meeting, April 21 Strategic Planning Meeting, April 20 Policy and Ordinance Committee Meeting, and April 30 Finance Committee Meeting

Audit Services Approved

The Board approved an engagement letter for the District's financial audit. The audit will provide an independent review of the District's financial statements and internal controls in accordance with governmental auditing standards.

Workforce Development Program Tabled

The Board discussed participation in the Alliance for Workforce Development's On-the-Job Training Program, which could provide partial wage reimbursement for qualifying new employees. The item was tabled pending additional information

Investment Options Reviewed

The Board reviewed options for investing District funds through certificates of deposit or money market accounts. Directors voted to table the item and directed staff to explore whether Plumas Bank could match the higher interest rate currently available through the District's CLASS investment account.

Fire Department ISO Compliance Purchases Approved

The Board approved the Indian Valley Fire Department's request to purchase equipment and materials needed to maintain and improve Insurance Services Office (ISO)

- An Office Manager position.

Closed Session Actions

During closed session, the Board discussed ongoing litigation and labor matters. No reportable action was taken regarding litigation matters.

Following closed session, the Board approved an amended employment agreement for General Manager Jamie Little. The agreement includes a limit of 20 hours per week, attendance at one regular Board meeting per month, and a process for Board Chair approval of additional hours when necessary.
